

Private Household Staff Salary Guide 2025/26

This guide compares live-in and live-out salaries for private household staff across the UK, Middle East, Europe, and USA. Figures represent typical ranges for high-net-worth (HNW) and ultra-high-net-worth (UHNW) households as of 2025/26. Actual salaries vary based on duties, experience, hours, and included benefits (accommodation, meals, flights, insurance).

Summary and Observations

- Live-in roles usually include accommodation, meals, and utilities (estimated value £10,000– \pm 30,000 per annum depending on quality and location).
- Live-out salaries are higher in cash terms to offset personal housing costs.
- In the Middle East, salaries are often tax-free with generous benefits (housing, flights, insurance).
- In Europe, salaries vary by country; Switzerland and Monaco command the highest levels due to cost of living.



• In the USA, total compensation can include healthcare, bonuses, and 401(k) matching for senior roles.
